The Bassetlaw Community Minibus is a wheelchair friendly minibus which is available to local community groups who need flexible, affordable and accessible solutions to their transport needs.

Bassetlaw Action Centre is a registered charity and therefore operates on a not for profit basis. To check the price or availability of the minibus, please call 01777 709650.

## Who can use the Minibus

The minibus is operated by Bassetlaw Action Centre under a Section 19 Minibus Permit which makes it available to not for profit community groups. Groups eligible to use the minibus would be those concerned with:

- Health and Social Welfare
- Sports
- Educational
- Environmental
- Religious Activities



## The Minibus

The minibus is fully wheelchair accessible with an under floor lift ensuring ease of access. Its features include:

- Seating capacity for up to 12 or 13 passengers - please ask for details
- Removable seats
- Hydraulic tail lift
- Hand rail and steps
- Can accommodate up to two fixed wheelchairs

If the lift is needed and passengers in wheelchairs need to be secured, seats will have to be reduced to accommodate this. There is space for securing two fixed wheelchairs safely, but this reduces the seating capacity.

## Benefits of the Community Minibus

The minibus has the facilities to enable wheelchair users to board and alight using a passenger lift and specialist equipment to secure both the user and their wheelchair.

Using our minibus ensures that your journey is more affordable, safe and legal as well as being provided in a properly serviced and well maintained vehicle.

The minibus will be maintained according to a strict maintenance regime and will have regular safety checks to ensure roadworthiness.

## Membership

Any not for profit community group or club wanting to make use of the service offered by the Bassetlaw Community Minibus are required to have daily or annual membership through the Bassetlaw Action Centre.

## Who will drive the minibus?

The minibus will be driven by Bassetlaw Action Centre registered and trained volunteer drivers. They will have been trained under the Community Transport Association's MiDAS training scheme.

This covers:

- Defensive driving
- Minibuses and the law
- Emergency procedures
- Comprehensive training in the safe use of passenger lifts
- Disability awareness
- Wheelchair handling
- Securing passengers in wheelchairs on the minibus
